Photoshopping basics Photoshop's interface is a bit different from other image editing programs.

It's not a "wizard" interface as some other image editors have, it has a flow that goes from top to bottom. If you are new to Photoshop, don't be afraid to click the "Image" button on the bottom bar, and start by creating a new file. You are free to click around inside Photoshop and not worry about accidentally saving the file. You can create files in various types including RGB, grayscale, CMYK, P3, TIFF, and many more. Don't worry too much about the type of file at this point, it doesn't matter

what type of file you create. When you have a new file, click File -> New and select the option for "Photoshop Document." This will create a new empty file in your current working directory. You will not see any white background in this type of file, which is different from most other image editors. If you have a document open, click File -> Close. The program should open with the default start screen. If you need to change the start screen, you can find the option to do so in the Help menu. If you are opening Photoshop for the first time, you will be asked if you want to sync files with the cloud. This is only the case if you have a Creative Cloud account and are using a computer that is connected to the internet. Step 2: Browsing to the Files tab Scroll down to the Files tab and you will see that it now has icons for your cloud storage such as Dropbox, Google Drive, OneDrive, and iCloud. Click on the icon for your cloud storage and Photoshop will browse to the folder where you have the files. The US Government Accountability Office or GAO is a watchdog group created in the early 1970's to objectively review government programs and operations. The GAO's investigative reports are published in the Federal Register to try and make government programs and operations more accountable and efficient. The GAO can also investigate issues pertaining to government programs or operations via their own investigative office in Washington DC. (CNSNews.com) – The GAO, an independent investigative office, released a report this week that found the United States Department of Education had misused funds given to it by Congress. The Department of Education had already been aware of the GAO's report that found mismanagement of Pell Grant funds, having received a 2014 audit report by the GAO on the subject in February. However, the department then failed to inform Congress or the American people in a timely fashion about the results of the report, prompting the GAO to inform Congress that it was withholding its March 2014 report on the subject. The report had been widely anticipated given that a number of Democrats had previously expressed concerns over the mismanagement of Pell Grant funds. While the GAO did not issue the report until last week, its findings came not too long after the department made a public pledge not to mismanage the funds that Congress had approved. "Under my direction, the Department will take all steps necessary to ensure that sufficient Pell Grant funds are distributed fairly, efficiently, equitably, and effectively," Secretary of Education John B. King Jr. said in a 2014 letter to the GAO. "We will take the strongest steps to ensure that these funds are not misused," King had promised. At that point, the GAO had already been carrying out a review of the Department of Education for Pell Grant funds since May 2013, even though the department's official response to the first, February 2014, audit report had been received in January. The GAO report explained that the department had failed to distribute a total of \$1.95 billion in Pell grant funds that had been approved by Congress, that was supposed to be given to low-income students to help with their college tuition costs. The actual total spent by the department, the GAO said, is \$1.7 billion, which is \$300 million less than the amount authorized by Congress. Spin relaxation of water holes in silicon. The reduction of the electron spin polarization in silicon caused by spin relaxation of water holes is investigated theoretically. In a strong magnetic field, we calculate analytically the field dependence of the polarization, treating spin-flip relaxation and spin-conserving recombination effects self-consistently. Two mechanisms of spin relaxation dominate: direct spin-flip scattering with phonon emission and spin-conserving recombination of electron hole pairs. The contribution of the spin-conserving process depends on the magnetic field, while the spin-flip mechanism gives the dominant contribution at low magnetic fields. For the magnetic field $B > 1$ T, the orientation of the hole spin polarization in silicon is almost independent of B , both due to the spin-conserving process and due to the long-range spin polarization of the outer valence shells.
